# PAWS`N PLAY PET CAMP, INC.

## Independent Contractor – Host Family Agreement



**IMPORTANT - READ WITH CARE:** This Agreement for Paws`N Play Pet Camp Care Services, effective as of \_\_\_\_\_ is made between PAWS`N PLAY PET CAMP, INC., a California Corporation (“Paws`N Play”) and the person(s) or entity providing Camper’s Host Family services (“Host Family”). The Host Family agrees to provide facilities and services to Paws `N Play under the terms of this Agreement and under terms contained in any and all forms supplied by Paws N’ Play in connection with the Camp Services.

### 1. PAWS `N PLAY CAMP SERVICES SUBJECT TO THIS AGREEMENT.

Paws`N Play provides an alternative pet care system aimed at fostering a healthy guest environment for each dog and cat (“Camper”) entrusted to its care. Paws`N Play will make all reasonable efforts to secure a safe and comfortable home environment for its Campers. Paws `N Play will offer each Camper his or her own space, his or her own bedding, and will allow each to receive regular contact with people (including daily walks), reasonable opportunities for play time, and will provide additional care services as necessary while the Parent is away.

Paws`N Play delivers Camp Services through a network of independent local providers (“Host Families”). Each Host Family is a local resident and will accept Campers into his, her or their homes for multiple days, weeks, or months, as the Parent’s needs require.

Training services may also be available for each Camper during his or her stay; however, these will be subject to a separate agreement and for an additional fee.

### 2. HOST FAMILY’S ASSURANCES AND ACKNOWLEDGEMENTS.

The Host Family warrants as follows:

- 2.1 It will work in good faith with Paws`N Play to accomplish all reasonable goals of providing quality facilities and services to Campers.
- 2.2 He, she or it is free to contract and nothing in this Agreement will result in a violation of any residential lease or any city or county ordinance or law restricting the number of animals permitted in a residence;
- 2.3 Host Family acknowledges that Host Family is not an employee, partner, or joint venturer with the Paws`N Play for any purpose. The Host Family is and will remain an independent contractor in its relationship to Paws`N Play.
- 2.4 Camper’s Host Family has safe and adequate space and facilities to care for the pet(s) as provided in this Agreement;

- 2.5 Host Family acknowledges that it will only provide facilities and services in connection with Paws`N Play and under terms and conditions of this agreement (or of a subsequent agreement). Host Family may not contract directly with customers of Paws`N Play without the express written consent of Paws`N Play. Host Family may not solicit customers for themselves or otherwise compete with Paws`N Play Pet Camp during the term of this Agreement and for at least one year after termination of this Agreement.
- 2.6 Host Family acknowledges that Paws`N Play reserves the right to refuse to provide its services for anyone and for any reason at its sole discretion.
- 2.7 In the event that Host Family has other animals, (i) such other animals have never bitten or exhibited aggressive behavior, towards any person or animal, and Host Family has no reason to believe that his or her other animals will not get along with the pet(s) being cared for under this Agreement; (ii) such other animals are free of fleas, ticks, worms and other insects and parasites; and (iii) such other animals have no contagious illnesses.
- 2.8 If Host Family has children, to Host Family's knowledge, such children are accustomed to, and not afraid of animals, and Host Family has no reason to believe such children will tease, mistreat or otherwise provoke the pet(s) being cared for under this Agreement in any manner that could reasonably be expected to result in injury to the child or the pet(s); and

### **3. HOST FAMILY'S RESPONSIBILITIES.**

The Host Family will care for Campers assigned to him, her, or it in a professional, safe, healthy and caring manner. The Host Family will perform the following:

- 3.1 The Host Family will take instructions for daily feeding regiments (as reasonably required) and/or application of medications from the Camper's Parent. Host Family will provide the pet(s) with fresh food and water on a daily basis in accordance with the pet(s)' normal feeding schedule as instructed by Camper's Parent;
- 3.2 The Host Family will follow marked instructions for any and all medications (whether prescription or otherwise) which are necessary for the Camper's proper care and will attain authorization to administer such medications.
- 3.3 The Host Family will contract for any veterinary or similar expenses needed while the pet is in the Host Family's care (to be reimbursed by the Camper's Parent or Paws`N Play). The Host Family shall receive authorization from both Paws`N Play and the Parent to seek veterinary care where such appears reasonably necessary under the circumstances.
- 3.4 Take all reasonable steps to ensure his or her home is safe and pet-friendly, including by placing poisonous plants and substances out of reach of the pet(s) and restricting unsupervised access to swimming pools, hot tubs and the like;
- 3.5.1 Take all reasonable steps to prevent the pet(s) from escaping, including by keeping doors and gates closed at all times and by always utilizing a leash when not in an enclosed area;

- 3.5.2 Groom the pet(s) in accordance with Camper's Parent's instructions; *provided*, that such grooming will include a complimentary bath if the stay is for over a week. Brushing (and not cutting, trimming or styling services) shall be provided as reasonably required unless otherwise agreed by Host Family, Paws`N Play and Camper's Parent. Additional grooming and/or related services other than as described herein may incur additional charges.
- 3.6 Provide the pet(s) with a clean, safe and friendly environment.
- 3.8 Provide the pet(s) with a loving home environment, both indoors and outdoors.
- 3.9 Provide the pet(s) with snacks, toys and playtime on a daily basis in accordance with Parent's instructions.
- 3.10 Provide sleeping arrangements for the pet(s) in accordance with Parent's instructions.
- 3.11 Allow sufficient opportunities for the pet(s) to relieve themselves throughout each day
- 3.12 Not, under any circumstances, strike, deprive of food or water, leave outside or in a vehicle in extreme weather or otherwise physically abuse, mistreat or knowingly or recklessly endanger the health or safety of the pet(s).
- 3.13 Exercise due care and supervision when allowing the pet(s) to interact or play with other animals or children;
- 3.14 Observe discipline, obedience and training regimens for the pet(s) as instructed by Pet Parent.
- 3.15 Walk the pet(s) or otherwise provide opportunities for the pet(s) to exercise on a daily basis in accordance with Pet Parent's instructions
- 3.16 Devote such time, energy and skill as is reasonably necessary for the performance of his or her duties under this Agreement and not leave the pet(s) unattended for extended periods of time.
- 3.17 Promptly notify Paws`N Play of any significant change in Host Family's residence, occupancy of the residence, employment status or other significant factors that may influence the suitability of the residence as a Camper's Hosting environment.
- 3.18 Allow representatives of Paws`N Play to visit and inspect Camper's Host's residence from time to time to ensure the suitability of the Camper's Hosting environment.
- 3.19 Host Family represents that he or she has adequate homeowners' or renters' insurance covering his or her residence and its occupants and contents; *provided*, however, that Host Family understands that such insurance coverage may contain exclusions or limitations relating to the provision of services for compensation from his or her residence. The Host Family shall obtain any and all permission required from third parties (including landlord or others) in order to effect the terms and conditions of this

agreement. Host Family accepts sole liability to receive such permission and agrees to indemnify Paws`N Play for any damages caused by failure to do so.

#### **4. HOST FAMILY'S COMPENSATION.**

- 4.1 Paws`N Play will pay Host Family for his or her services according to Paws`N Play's standard fee schedule, as amended from time to time by Paws `N Play. Regardless, at the time that this Agreement is executed, the current fee is 50% of the entire scheduled price (70% for Camper`s procured by Host Family)for services with the Camper`s Parent.
- 4.2 Host Family will be responsible for all expenses incurred while performing services under this Agreement except (a) pet food and medicine, both of which will be provided by Parent and (b) subject to the following sentence, veterinary expenses. Host Family acknowledges and agrees that Parent is required to make payment prearrangements for veterinary care. If for any reason, however, such prearrangements are not made or are inadequate, and a Paws`N Play representative cannot be reached, Host Family agrees to advance any emergency veterinary costs necessary to save the pet's life or treat critical injuries or illness, consistent with Parent's instructions; *provided*, that all such costs will be reimbursed by Parent or Paws`N Play as soon as practicable thereafter.

#### **5. TERM AND TERMINATION**

This Agreement shall continue in force and effect for a period of one (1) year and shall automatically renew for an additional one year period unless terminated by written notice to the other party. Either party may terminate this Agreement at any time, with or without cause, upon 10 days written notice to the other party. Either party may terminate this Agreement at any time, for breach of any provision of this Agreement, immediately upon written notice to the other party. Notwithstanding the foregoing, except in case of emergency, if this Agreement is terminated while a pet is in Host Family's care, such termination will not become effective and this Agreement will remain in full force and effect for so long as such pet is in Host Family's care.

**6. WARRANTY. THE SERVICES OF PAWS`N PLAY PET CAMP ARE PROVIDED ON AN "AS IS" BASIS WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, NON-INFRINGEMENT, AND ANY WARRANTY AGAINST LATENT DEFECTS. PAWS`N PLAY DOES NOT WARRANT THAT THE OPERATION OF THE PET CARE SYSTEM WILL BE ERROR FREE OR THAT INJURY TO EITHER ANIMAL OR PERSON MAY BE INCURRED. PAWS`N PLAY MAKES NO WARRANTIES OR REPRESENTATIONS WHATSOEVER REGARDING ANY GOODS OR SERVICES PROVIDED BY ANY THIRD PARTIES (INCLUDING HOST FAMILYS) PURSUANT TO YOUR USE OF THE SYSTEM AND PAWS`N PLAY SHALL NOT BE LIABLE FOR ANY COSTS OR DAMAGES ARISING OUT OF, EITHER DIRECTLY OR INDIRECTLY, THE ACTIONS OR INACTIONS OF SUCH THIRD PARTIES.**

**7. LIMITATION OF LIABILITY. PAWS`N PLAY SPECIFICALLY DISCLAIMS LIABILITY FOR ANY AND ALL DIRECT, INDIRECT, SPECIAL, GENERAL, PUNITIVE, EXEMPLARY, AGGRAVATED, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, EVEN**

IF ADVISED OF THE POSSIBILITY THEREOF, WHETHER FORESEEABLE OR UNFORESEEABLE, OF ANY KIND WHATSOEVER, INCLUDING BUT NOT LIMITED TO DESTRUCTION OF PROPERTY; LOSS OF CONSORTIUM; PROFITS; OR OTHER ANTICIPATED BENEFITS; DAMAGES OR COSTS INCURRED AS A RESULT OF, OR ARISING OUT OF USE OF THE PET CARE SYSTEM. IN RESPECT OF ANY CLAIM RELATED TO THE PET CARE SYSTEM. IN ANY EVENT, PAWS`N PLAY'S LIABILITY SHALL NOT EXCEED THE ACTUAL PRICE PAID FOR THE LICENSE TO UTILIZE SERVICES UNDER THE PET CARE SYSTEM.

**8. INDEMNIFICATION.** HOST FAMILY WILL INDEMNIFY, DEFEND, AND HOLD HARMLESS BOTH PAWS`N PLAY AND CAMPER`S PARENTS FROM AND AGAINST ANY AND ALL LOSSES, LIABILITIES, DAMAGES, FINES, PENALTIES, AND EXPENSES (INCLUDING ATTORNEY`S FEES) ARISING FROM OR RESULTING FROM ANY BREACH OF THE HOST FAMILY`S REPRESENTATIONS, WARRANTIES OR COVENANTS.

**9. CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT**

Host Family has received (or will receive) information, documents and supplies, such as, but not limited to: company advertising, memos, records, correspondence, notebooks, files, or any such other supplies provided by Paws`N Play in either electronic, oral, or documentary form. These items contain certain Confidential Information of Paws`N Play and are its unique and valuable property. Host Family acknowledges that he or she will make all best efforts at protecting the Confidential Information and will not use such information to Paws`N Play`s disadvantage, and acknowledges that but for his or her adhering to these confidentiality provisions, Paws`N Play would not have entered into this Agreement. Host Family furthermore agrees not to compete with Paws`N Play by operating any similar business in San Diego County during the term of this Agreement and for a period of one (1) year after the termination of this Agreement.

**11. LAW.** This Agreement shall be construed in accordance with the laws of the State of California.

The Parties have read, understood and accept the terms of this Agreement.

I understand as an IC, I am not entitled to any benefits on behalf of *Paws`N Play Pet Camp* including but not limited to, health insurance, unemployment or workman's compensation.

I understand I am solely responsible for the payment of any and all taxes myself or my employees earn. *Paws`N Play Pet Camp* will not withhold any payroll tax deductions from earnings.

As an IC of *Paws`N Play Pet Camp*, I agree to be compensated 50% on all jobs completed by myself or my employees for *Paws`N Play Pet Camp* or 70% if I procure the client. These monies shall be paid promptly on the 1<sup>st</sup> and 15<sup>th</sup> of each month.

This agreement shall remain in effect until terminated by either party in writing. At the point of termination, all monies due from *Paws`N Play Pet Camp* shall be immediately paid.
